1           **AN ORDINANCE AMENDING THE JEFFERSON COUNTY, MISSOURI,**  
2           **CODE OF ORDINANCES, TITLE III, SCHEDULE III OF THE TRAFFIC CODE,**  
3           **AND PROVIDING FOR AN EFFECTIVE DATE THEREOF, AFFECTING**  
4           **COUNCIL DISTRICTS 1, 2, 3, 4, 6, AND 7.**

5           **WHEREAS,** the Jefferson County, Missouri, Council, (hereafter "Council")  
6           previously enacted the Jefferson County, Missouri, Code of Ordinances, Title III-Traffic  
7           Code, (hereafter "Traffic Code") for the purpose of controlling vehicular traffic upon the  
8           public roads and highways in the unincorporated area of Jefferson County, Missouri; and,

9           **WHEREAS,** the Council has amended, from time to time, the Traffic Code when  
10          deemed necessary and appropriate; and,

11          **WHEREAS,** the Council desires to further amend the Traffic Code; and,

12          **WHEREAS,** the Public Works Department has recommended deleting Winter  
13          Valley Drive from the Williamsburg Subdivision and adding a second stop sign location  
14          on Belmont in the Capetown Village Subdivision, adding two stop sign locations on Kings  
15          Crossing Drive and William and Mary Court, adding St. Luke's Church Road, and reducing  
16          the speed limit from 25 MPH to 20MPH on Armistead Avenue, Armistead Court, Kings  
17          Crossing Drive, Lafayette Court, and William and Mary Court in the Williamsburg  
18          Subdivision, and Winter Bluff Court, Winter Bluff Drive, Winter Lake Court, and Winter

1 Lake Drive in the Winter Bluff Estates Subdivision, and adding Samarra Estates Drive in  
2 the Winter Bluff Estates/West Grove Condominiums Subdivision in order to clarify the  
3 roads, speed limits, and stop sign locations; and,

4 **WHEREAS**, the Public Works Department has assumed maintenance of  
5 roadways within the Brooks Farm Estates, Creekside, Corisande Crossing, Fountains at  
6 Moss Hollow, Joshua Crossing, La Bon Country Estates, Northwest Point/Fawn Hollow,  
7 Remington Place-Phase 1, and Whitehall Estates Subdivisions, and are now recommending  
8 that the aforementioned subdivisions be added to Schedule III for the purpose of traffic  
9 control enforcement; and,

10 **WHEREAS**, the Council conducted public hearings as required by Section  
11 304.130 RSMO for the purpose of receiving public comments regarding proposed  
12 amendments to the Traffic Code; and,

13 **WHEREAS**, the Council finds that it is in the best interests of Jefferson County,  
14 Missouri, to adopt the proposed amendments to the Jefferson County, Missouri, Code of  
15 Ordinances, Title III, Schedule III.

16 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNTY**  
17 **COUNCIL, AS FOLLOWS:**

18 Section 1: The Jefferson County, Missouri, Code of Ordinances, Title III,  
19 Schedule III is hereby amended as follows:

1            Section 2: Copies of the amended Jefferson County, Missouri, Code of Ordinances,  
2 Title III, Schedule III, shall be kept on file in the office of the County Clerk and the same  
3 shall be codified into the Jefferson County Code of Ordinances.

4            Section 3: A copy of this Ordinance shall be published in a newspaper of general  
5 circulation in Jefferson County, Missouri, and posted in a public place in each Council  
6 District and on the Jefferson County web page, as required by Article III, Section 3.5.4 of  
7 the Home Rule Charter of Jefferson County, Missouri.

8            Section 4: This Ordinance shall be in full force and effect thirty (30) days after it  
9 has been posted and published as required by Section Three (3) above. If any part of this  
10 Ordinance is invalid for any reason, such invalidity shall not affect the remainder of this  
11 Ordinance.




