1           **A RESOLUTION AND ORDER OF THE JEFFERSON COUNTY,**  
2 **MISSOURI, COUNTY COUNCIL TO APPROVE THE REDISTRICTING PLAN**  
3 **OF THE JEFFERSON COUNTY REDISTRICTING COMMISSION FOR**  
4 **JEFFERSON COUNTY, MISSOURI.**

5           **WHEREAS,** The Home Rule Charter for Jefferson County (“County Charter”) was  
6 submitted to the qualified voters of Jefferson County and was thereby passed at the  
7 November 2008 general election; and,

8           **WHEREAS,** Article XIV of the County Charter requires, in part, that the County  
9 Council appoint a Redistricting Commission within sixty days after the publication of the  
10 results of each decennial census of the United States of America consisting of two persons  
11 designated by each serving Council Member as set forth in Section 14.1.1; and,

12           **WHEREAS,** Public Law (P.L. 94-171), enacted by Congress in December 1975,  
13 requires the Census Bureau to provide states the opportunity to identify small area  
14 geography for which they need data in order to conduct legislative redistricting; and,

15           **WHEREAS,** the full redistricting data toolkit and data under said Public Law was  
16 released on September 16, 2021, which now allows Jefferson County to utilize said data to  
17 draw the necessary and legal Council District boundaries as required every ten years under  
18 the guidance of the County Charter; and,

1           **WHEREAS**, pursuant to County Council Resolution R21-1003 the County  
2 Council appointed a Redistricting Commission, the make-up of which was revised pursuant  
3 to later resolutions, specifically, R21-1101 and R21-1201; and,

4           **WHEREAS**, once said Commission was duly appointed, it convened, met, and  
5 voted on and approved a Redistricting Plan based on the data provided to the Commission  
6 pursuant to the United States Census and under the terms and conditions of the County  
7 Charter. (Said Plan is attached hereto as Exhibit A); and,

8           **WHEREAS**, said Charter provisions require that within ten (10) days after  
9 receiving said Plan the County Council must by an affirmative vote of All Council Votes  
10 either approve or reject said plan and that if the Plan is rejected the County Council must  
11 advise the Commission of the objections of those Council members who voted to reject the  
12 same; and,

13           **WHEREAS**, the Commission filed the plan as contained in Exhibit A with the  
14 County Clerk of Jefferson County, Missouri, on January 26, 2022.

15           **NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE**  
16 **JEFFERSON COUNTY, MISSOURI, COUNCIL, AS FOLLOWS:**

17           Section 1. The Jefferson County, Missouri, Council hereby approves and adopts  
18 the Redistricting Plan as submitted by the Jefferson County Redistricting Commission and  
19 shown in Exhibit A.

20           Section 2. Copies of the Plan shall be kept on file in the office of the County  
21 Clerk of Jefferson County, Missouri.

1            Section 3. This Resolution and Order shall be in full force and in effect from and  
2 after the date of this enactment.

3            Section 4. If any part of this Resolution and Order is invalid for any reason, such  
4 invalidity shall not affect the remainder of this Resolution and Order.
