9           **WHEREAS**, The County of Jefferson Missouri passed Ordinance No. 19-0133 on  
10 February 11, 2019, to authorize Jefferson County to request funding for roadway and  
11 bridge projects and to authorize the County Executive, as the authorized County  
12 representative, to execute the necessary documents for the 2020-2023 Transportation  
13 Improvement Program STP-S applications; and

14           **WHEREAS**, The County of Jefferson, Missouri passed Ordinance No. 20-0139 on  
15 February 10, 2020, to authorize Jefferson County to enter into a Surface Transportation  
16 Program Agreement (STP) and to authorize the County Executive, as the authorized  
17 County representative, to execute the agreement for federal reimbursement for up to 80%  
18 of design, right-of-way, construction, and construction engineering activities for the

1 replacement of the Laguna Palma Road bridge, designated as Project STP-5403 (697),  
2 subject to budgetary limitations; and,

3         **WHEREAS**, The County of Jefferson, Missouri passed Ordinance No. 20-0140 on  
4 February 10, 2020, to authorize Jefferson County to enter into a Surface Transportation  
5 Program Agreement (STP) and to authorize the County Executive, as the authorized  
6 County representative, to execute the agreement for federal reimbursement for up to 80%  
7 of design, right-of-way, construction, and construction engineering activities for the  
8 replacement of the McGehan Road bridge, designated as Project STP-5403 (698), subject  
9 to budgetary limitations; and,

10         **WHEREAS**, the Jefferson County, Missouri, Council finds it is in the best interest  
11 of the County to combine these two bridge replacement projects into a single project, to be  
12 known as the South Jefferson County Bridge Replacement Program, and enter into a  
13 Surface Transportation Program (STP) Supplemental Agreement with the Missouri  
14 Highways and Transportation Commission which allows Jefferson County to designate a  
15 single project number and combine the funding of the Laguna Palma Bridge Replacement  
16 Project with the McGehan Road Bridge Replacement Project which includes federal  
17 reimbursement of up to 80% for design, right-of-way, construction, and construction  
18 engineering activities up to a maximum of one million, six hundred ninety-six thousand  
19 dollars and no cents (**\$1,696,000.00**), subject to budgetary limitations. A copy of said  
20 agreement is attached hereto as Attachment A.

21         **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,**  
22 **AS FOLLOWS:**



1           Section 1:     The County shall execute the Surface Transportation Program  
2 (STP) Supplemental Agreement with the Missouri Highways and Transportation  
3 Commission to combine the Laguna Palma Bridge Replacement Project with the McGehan  
4 Road Bridge Replacement Project, to be designated as Project STP-5403 (697), for up to a  
5 maximum of one million, six hundred ninety-six thousand dollars and no cents  
6 **(\$1,696,000.00)** subject to budgetary limitations.

7           Section 2:     The Jefferson County, Missouri, Council hereby authorizes the  
8 County Executive to execute the supplemental agreement set forth in this Ordinance. A  
9 copy of said agreement is attached hereto as Attachment A. The County Executive is  
10 further authorized to take any and all actions necessary to carry out the intent of this  
11 Ordinance.

12           Section 3:     Copies of all Invitations for Bid, response thereto, any contract  
13 agreements and change orders shall be maintained by the Department of the County Clerk  
14 consistent with the rules and procedures for the maintenance and retention of records as  
15 promulgated by the Secretary of State.

16           Section 4:     This Ordinance shall be in full force and effect from and after its  
17 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity  
18 shall not affect the remainder of this Ordinance.

7           **WHEREAS**, a hearing was held by the Planning and Zoning Commission of

16           b.       The Jefferson County, Missouri, Council has jurisdiction over the

18           c.       The requested change in zoning is consistent with the intent stated  
19 for the Planned Commercial (PC) zone district.

20           d.       The requested change in zoning is in accordance with the Official  
21 Master Plan of Jefferson County, Missouri.

1 e. The requested change in zoning is in harmony with and is  
2 compatible with surrounding and adjacent land uses and properties.

3 f. The requested development plan, as conditioned and modified by  
4 this Ordinance, is consistent with the UDO in that the development plan is  
5 designed, located and proposed to be operated so that the public health, safety and  
6 welfare will be protected.

6 Section 1. Application Number: PC21021 an application to rezone 40.8 acres  
7 from Non-Planned Community Commercial (CC2) zone district and Single Family  
8 Residential (R40) zone district to Planned Commercial (PC) zone district and a  
9 development plan on the real estate described as Parcel Numbers: 18-7.0-26.0-0-002-018  
10 and 18-8.0-27.0-0-001-001.01, for Checkered Flag Enterprises, is hereby approved  
11 subject to the following modifications, regulatory requirements, departmental comments,  
12 and the following conditions of approval:

13 **Modifications:**

- 14 1. Approval of the requested modification from Section 400.4100 – Requirements  
15 for Design and Improvement of Parking Lots to allow a gravel lot within the  
16 bounds of the “Equipment Parking and Material Storage” area.

17 **Regulatory Requirements**

18 *Permitted Uses*

- 19 Construction Contractor (with machinery, equipment, and storage),  
20 Building Contractor Office,  
21 Equipment sales, Rental, and Service (Heavy)

2                   Maximum Structure Height: 70 feet

3                   *Site Development*

4                   *Required Setbacks:*

5                               Front Yard: 20 feet

6                               Side Yard: 15 feet

7                               Rear Yard: 20 feet

8                   *Design Standards*

9                   The development shall comply with the Suburban Design Standards in  
10                   accordance with Article VII of the Jefferson County Unified Development  
11                   Order.

12                   *Access*

13                   Access shall be provided in accordance with the Jefferson County Unified  
14                   Development Order.

15                   *Parking*

16                   Parking and loading shall be provided per the regulation of Article XII of  
17                   the Jefferson County Unified Development Order, except as specifically  
18                   modified by this Ordinance.

19                   *Signs*

20                   Signs shall comply with Article XIII of the UDO. All regulatory signs,

#### 11 *Geotechnical*

12 A geotechnical study prepared by an Engineer licensed in the State of  
13 Missouri shall be required where there is more than 5 feet of cut or 5 feet  
14 of fill or slopes greater than 3:1. Where grades are proposed at slopes than  
15 3:1 slope stability must be addressed in the study.

#### 16 *Noise*

17 No operation shall be carried on that involves noise in excess of the  
18 normal traffic noise of the adjacent street at the time of the daily peak hour  
19 of traffic volume. Noise shall be measured at the property line and when  
20 the level of this noise cannot be determined by observation with the  
21 natural senses, a suitable instrument may be used, and measurement may  
22 include breakdowns into a reasonable number of frequency ranges. All

1 noise shall be muffled so as not to be objectionable due to intermittence,  
2 beat frequency or shrillness.

3 **Departmental Comments:**

4 1. Pavement:

5 a) An entrance permit required for access onto a Festus Special Road District road.

6 b) Driveway entrances (within state/county ROW):

7 i) Pavement thickness shall include 6" PCC (or 2" Type C Asphaltic Concrete  
8 /5" Type X Asphaltic Concrete/4" rock base). Thickness is unknown,  
9 pavement shows signs of distress. Core to prove thickness or provide 2"  
10 asphalt overlay.

11 ii) The entrance width shall be provided from the street into the site for a throat  
12 length of 60'.

13 iii) Pavement width for entrance at ROW (including curbs) for two-way traffic  
14 shall provide 36'–54'.

15 2. Parking areas:

16 a) Parking areas with 5 or more required parking spaces must provide a paved  
17 surface of 3" Type C Asphaltic Concrete over an 8" rock base (or 2" Type C  
18 Asphaltic Concrete/4" Type X Asphaltic Concrete; or 6" PCC). Core to prove  
19 thickness or provide 2" overlay.

20 b) Contractors storage yard must provide an 8" rock base minimum.

21 c) Setbacks:

- 1 i) Parking areas in commercial/industrial developments with 50 or more parking  
2 spaces shall provide at least 20' setback for the parking area.
- 3 ii) Commercial and Industrial districts, any parking or loading area visible from a  
4 street shall be separated from the street ROW with a 20' landscape strip.
- 5 d) No parking space shall be located within the entrance throat.
- 6 e) Straight back curbing (concrete or asphalt) is required around parking areas.
- 7 f) Pavement shall slope between 1% and 6%.

8 3. Stormwater/detention:

- 9 a) Detention system shall detain and release stormwater at a rate not to exceed the  
10 release rate from the site under the existing (pre-developed) conditions for the 2-  
11 year and 10-year, 24-hour storm event. Provide soil types, CN's, etc.

12 4. Grading:

- 13 a) Submit a geotechnical report, sealed by an Engineer registered in the State of  
14 Missouri, as required where more than 5' of cut or 5' of fill is proposed. Grades at  
15 slopes proposed steeper than 3:1 must be included in the report for slope stability.

16 **Conditions of Approval:**

- 17 1. A Site Development Plan shall be submitted to the Jefferson County Planning  
18 Division in accordance with the Unified Development Order (UDO) of  
19 Jefferson County.
- 20 2. A copy of the approved Development Plan incorporating any conditions and  
21 approved modifications shall be attached to each set of Site Development

**Section 400.2770. Accessory Uses, Buildings and Structures**

D. Standards For Accessory Structures In Residential Zoning Districts. Accessory structures may be allowed in residential zoning districts under the following conditions:

~~7. Accessory structures for which a building permit is required, including but not limited to pools, shall also require submission of a site plan that meets the requirements of Section 400.430.~~

**Section 400.5250. Proof Improvements Will Be Completed.**

B.
