V. County Business

A. Public Nuisance Process

Director of County Services Eric Larson gave a presentation on Public Nuisance, explaining the departments receiving complaints – Solid Waste, Code Enforcement, Animal Control, and Planning. He described the various types of nuisances to include flood property, tall grass, and derelict vehicles. Mr. Larson spoke of the stats for active and closed cases, budget constraints, solutions, timeframes, options for non-compliance, the current process, and future funding options. County Executive Gannon described an example of a problem he is aware of. There were questions from Council, responded to by Mr. Larson.

B. Derelict Property List

Director of County Services Eric Larson distributed handouts and presented a PowerPoint describing derelict property, homes in disrepair, he spoke of a top ten list, and costs to demolish homes and derelict vehicles. There were questions and comments from Council Members, and County Executive Gannon, with statements about necessary funding, triage, the complaint process, the possibility of utilizing Americas Rescue Plan dollars, and the lengthy process to acquire input. Mr. Larson will explore participation by HOAs and the EDC.
