BID DOCUMENTS:

1. Page 0030 – BID FORM 2 and Page 00460 Agreement Form 2; Bid Item 104 – 4” PVC Gravity Sewer, change the Unit from Cu. Yd. to Lin. Ft. (4” PVC Gravity Sewer 2625 Lin. Ft.)
2. Page 0030 – BID FORM 2 and Page 00460 Agreement Form 2, Service Connection, See Plan Sheet 8 of 8 Construction Standards for Typical Service Connection Details.
3. Page 0030 – BID FORM 2 and Page 00460 Agreement Form 2; Bid Item 115 and 116 – Clarification: The home owner will make the septic tank accessible. That is, if the septic tank is inaccessible due to a permanent construction (i.e. porch, garage) then the home owner will be responsible for making the septic tank accessible.

Item 126, Contractor Construction Staking. and Page 00500- General Conditions 3; Part 9, Survey: Clarification, Contractor is responsible for all construction staking. Engineer will make available coordinate geometry of control points and sewer main alignment for the contractor.

DRAWINGS:

1. Page 2 of 8; Erosion Control, 1), Substitute the work Contractor for the word Owner. I.e. The Contractor assumes complete responsibility for installation/maintenance of project erosion control measures....,
2. Page 6 of 8; laterals for Lot 20 and 21 Short Dr, Lots 10-10a Bow Dr. will be connected to the sanitary sewer. Laterals for lots 19 Bow Drive and Lots 9 and 11 Short Drive will be will extend to 10 past the creek and capped. The capped will be marked with a pressure treated wood marker that extends two feet above ground. 6" Ductile Iron pipe shall be used for the creek crossings.
3. Page 7 of 8; Restrained Joint piping shall be used for any pipe Installed at 20% +/-.
4. Page 8 of 8; Service Connections refer to the installation of the Elder Valve and Riser pipe. Coordinate location of service connection with Sewer District.
