Note also that every page has a dropdown on hover on the header menu, and the header menu remains static when you scroll down the page. That was my implementation.

PDF Integration Rowenskeg

On the main properties listing page the share hover has a link to the PDF version of the property listing. Idid the PDF integration. Also the full style of the sub property pages.

Custom Opencart with CURL integration

The client sells gold, sliver, and platinum products, which change in price every five minutes. I installed and customized Opencart to have additional fields: weight of item, type of metal, percent above spot price, and dollars above spot price. I created a CRON job script to fetch data from Kitco.com and update the entire product catalog. It currently runs every five minutes to the client has the most up-to-date pricing on his website.

Early in the project I recommended to the client that he get a web host with cpanel, the industry standard. The control panel of his web host was inferior. He insisted on staying with them, so I spent two days working with them to make the hosting environment work properly with the existing shopping cart system. This included upgrading the servers to PHP 5.3, updating the PHP ini file to allow CURL, and upgrading his plan to include scheduled tasks.

Summary - Grapevine Uncorked

The website lists 15,000 global wineries and 250,000 wines. I made significant changes to the website on the backend, frontend, and database schema.

Google Maps API - Grapevine Uncorked

There are 15000 wineries listed on the website. On the homepage scroll down to Uncorked Maps. I extended a batch geolocation processor to include the addresses of each winery. There was a problem with the script because most of the wineries had international language codes, so I created a regex to filter out the non-standard characters. Winery Locations are geocoded to the longitude and latitude which I added to the database schema, so only one lookup is required per winery.

If you notice on Uncorked Maps, there are circles instead of pins. Click a circle to zoom in, and click another circle, and you can drill down to the pins by location. I implemented Google MarkerClusterer to allow this functionality. If you create an account you can see the Grapevine Elite Community tab. I implemented the geolocation for the users as well.

jQuery - Grapevine Uncorked

There was a complete redesign of the homepage, integrating the blog with the articles section for one thing. I decided the best location for the Joomla blocks on the page, and modified the header information with jQuery. It is a three column layout and to span two columns requires some fancy CSS/jQuery.

Facebook Integration - Grapevine Uncorked

The Sign in with Facebook functionality on the top right of the website was not working properly. I did troubleshooting and resolve the issue.

Backend PHP Coding

I created the Grapevine Elite: The Top 5 module in PHP/HTML/CSS/SQL for Joomla on the homepage. I created the <u>awards page</u> along with a second page for the users to see which awards they have won. There is complex logic for four types of medals. The most interesting one is where the visitor is allowed to go to a winery, which has previously been emailed a code. This code is then entered to the website, which confirms that the user has visited the winery. I set this up, and made it so when all wineries in a particular medal were visited, the medal was awarded along with a specified number of points. There are about 15 hooks for awarding points that I added as well.

Database Schema - Grapevine Uncorked

Modified eight tables and created three more to accommodate the source code changes I made. I integrated with about thirty tables on the backend as well.

SQL Optimization - Grapevine Uncorked

There was a full join query that slowed down a particular page to 30 seconds. The cause was a query with two mistakes. There was a FULL JOIN on three tables, which has exponential memory usage and loadtime. There were multiple usages of the LIKE operator. I changed the FULL JOIN tables to INNER JOINs and when that wasn't enough created another table to cache the results and ran a batch script to populate. This brought the load time to2 seconds, searching a million records.


