COMMUNITY MENTAL HEALTH FUND

HILLSBORO R-3 SCHOOL DISTRICT

PROPOSITION B (4/7ths majority)

For the purpose of providing funds for the acquisition, constructing, equipping, furnishing and betterment of school facilities, including, the constructing, equipping, and furnishing of a new high school, shall the Board of Education of the Hillsboro R-III School District of Jefferson County, Missouri, borrow money in an amount not to exceed Seven Million Three Hundred Eighty-Five Thousand Dollars (\$7,385,000) and issue bonds for the payment thereof?
