Missouri Court of Appeals Judges, Eastern District

CONSTITUTIONAL AMENDMENT NO. 1Proposed by the 89th General Assembly (First Regular Session) HJR 16

Changes the deadline for submitting initiative petitions from four months prior to the election to six months prior to the election. The proposal would have no direct fiscal impact.

CONSTITUTIONAL AMENDMENT NO. 2Proposed by the 89th General Assembly (First Regular Session) HJR 9, Part A

School board may set operating levy no higher than \$2.75 without a vote. Voter approval by simple majority required to set levy up to \$6.00. Voter approval by two-thirds required to set levy above \$6.00.

CONSTITUTIONAL AMENDMENT NO. 5Proposed by the 89th general Assembly (First Regular Session) HJR 18

State treasurer to prepare a written investment policy for investment of state funds and authorizes additional categories of permitted investments to include banker's acceptances and commercial paper. The amendment is intended to increase earnings on investments of the state.

CONSTITUTIONAL AMENDMENT NO. 6Proposed by the 89th General Assembly (First Regular Session) HJR 11

Allows financing of municipal or joint sewer improvement project by issuance of revenue bonds. Local government costs, if any, to implement this proposal are at the option of political subdivisions. No state costs are anticipated.

CONSTITUTIONAL AMENDMENT NO. 7Proposed by the 89th General Assembly (Second Regular Session) SJR 24

Authorizes the State to issue bonds to fund distributions by the Missouri Clean Water Commission of water and sewer grants or loans to counties, municipalities, sewer and water districts for design, construction or improvements to public sewerage collection and treatment facilities, drinking water systems and stormwater control projects. Assuming the general assembly authorized the issuance of these bonds, the fiscal impact of this constitutional amendment to the state is approximately \$17,300,000 annually in bond principal and interest payments and other costs over a 35 year period. Local governments which choose to participate will incur some of these costs.

CONSTITUTIONAL AMENDMENT NO. 8

Proposed by the 89th General Assembly (Second Regular Session) HJR 39

Shall the Missouri Constitution be amended to permit organizations recognized as charitable or religious under federal law to sponsor raffles and sweepstakes and also permit the general assembly to provide standards and conditions to regulate or guarantee the awarding of prizes provided for in such raffles or sweepstakes? The estimated fiscal impact of this proposed measure on state and local governments is \$0.

CONSTITUTIONAL AMENDMENT NO. 9

Proposed by Initiative Petition

Shall the Missouri Constitution be amended to authorize the general assembly to permit upon the Mississippi and Missouri Rivers only, including artificial spaces containing water that are within 1000 feet of the closest edge of the main channel of either of those rivers, lotteries, gift enterprises and games of chance to be conducted on excursion gambling boats and floating facilities and to provide that any license issued before or after the adoption of this amendment for any such boat or facility located in any such artificial space shall be deemed authorized by the general assembly and compliant with this section? The fiscal impact to state and local governments of adopting this constitutional amendment is the continuation of revenues ranging from approximately \$95,000,000 to \$170,000,000 annually, that are currently received from gambling boats and floating facilities that most likely could not continue to be licensed under the present constitution.

STATUTORY MEASURE

Proposition A - Proposed by Initiative Petition

Shall a statute be enacted making it a class D felony to bait or fight animals; permit such activities on premises you control; or promote, conduct, stage, advertise or collect fees for such activities; and making it a class A misdemeanor to knowingly attend baiting or fighting or animals; knowingly sell, offer for sale, or transport animals for such purposes; own, possess, manufacture or deal in cockfighting implements; bear wrestle; permit bear wrestling on premises you control; promote, conduct, stage, advertise, or collect fees for bear wrestling; or market, possess, train, or surgically alter a bear for bear wrestling? The estimated fiscal impact of this proposed measure on state and local governments is \$0.

JEFFERSON COUNTY**Road Improvement Sales Tax - Proposition R**

Shall the County of Jefferson amend the Road Improvement Sales Tax adopted by voters on April 1, 1986, by renewing this current countywide sales tax at the rate of one-half of one per cent (1/2 of 1%) for a period of fifteen years from the expiration of the current tax for the purpose of capitol improvements to the publicly maintained roads of both the unincorporated and incorporated areas of Jefferson County based upon a population and mileage formula?

Meramec Valley R-3 School District**Proposition No. 1**

Shall the Board of Education of Meramec Valley R-III School District, Franklin, St. Louis, and Jefferson Counties, Missouri, be authorized to incur an indebtedness of said District in the amount of Six Million, Five Hundred Thousand Dollars (\$6,500,000) for the purpose of purchasing schoolhouse sites, erecting schoolhouses, building additions to and repairing old buildings, and furnishing schoolhouses in said District and to evidence such indebtedness by the issuance of bonds of said District in said amount for said purpose?

Proposition No. 2

Shall the Board of Education of the Meramec Valley R-III School District, Franklin, St. Louis and Jefferson Counties, Missouri be authorized to increase the operating levy ceiling of the district to \$3.23 per one hundred dollars of assessed valuation and fully waive the sales tax rollback to the operating tax levy to fund current operating and capital outlay costs, including but not limited to acquisition and betterment of school facilities, furnishing and equipping school facilities, and for staffing and operating the facilities of the school district?

If this proposition is approved, the adjusted operating levy of the school district is estimated to increase from \$2.75 currently to \$3.23 per one hundred dollars of assessed valuation.

Kingston K-14 School**Proposition 1**

Shall the Board of Education of the Kingston K-14 School District, Missouri, borrow money in an amount not to exceed Two Million Dollars (\$2,000,000) for the purpose of providing funds for the acquisition, constructing, equipping, furnishing and betterment of school facilities, including, without limitation, the constructing, equipping, and furnishing of a new elementary school and to complete other remodeling and repair improvements to the existing facilities of the District, and issue bonds for the payment thereof?

Special School District of St. Louis County**Proposition S**

Pursuant to Section 162.858 RSMo, the Public Review Committee has conducted a review of the Special School District of St. Louis County ("SSD") and made certain recommendations regarding the governance thereof, including the submission to voters the question of whether the way SSD board members are chosen should be modified. Presently, members are elected to the Board of SSD by subdistricts by the voters of those subdistricts. Under the following proposition, Board members would be elected by the SSD Governing Council, which is a board made up of elected members of each local school district served by SSD. All current SSD Board members will be entitled to serve out the terms for which they were most recently elected.

PROPOSITION: Shall the procedure for selecting members of the Board of Education of the Special School District of St. Louis County ("SSD") be changed so that beginning in April 1999, members of the SSD Board of Education will be elected from those subdistricts by the entire SSD Governing Council rather than by the voters of those subdistricts; provided, however, that all Board members presently serving shall be entitled to complete the term for which they were most recently elected?

HEMATITE FIRE PROTECTION DISTRICT

Proposition No. 1

Shall the Board of Directors of the Hematite Fire Protection District be authorized to levy an additional tax of not more than twenty-five cents on the one hundred dollars assessed valuation to provide funds for the support of the district?
