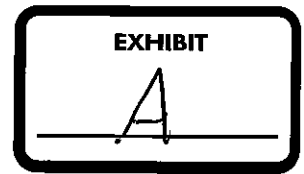

**Effective: January 1, 2016 to December 31, 2016**

Correctional Healthcare Companies, Inc. (CHC) will continue providing professional healthcare services at the Jefferson County Jail in accordance with the contract executed on January 1, 2014. Please refer to the contract and any subsequent amendment(s) for complete scope of staffing and services provided.

CHC submits the following Cost Proposal to Jefferson County for the renewal period, incorporating all services that will be provided to the County:

\$30,537.29 per month (Current Cost)  
\* 2.38% CPI Increase  
= **\$31,264.08 per month (Renewal Cost)**  
**\$375,168.96 annually**

For professional health care services rendered at the Jefferson County Jail, CHC will charge \$31,264.08 per month from January 1, 2016 through December 31, 2016.
