15 WHEREAS, the Department of Public Works of Jefferson County, Missouri,  
16 requested the awarded bidders an option to renew the On-Call Sewer Contractor Contract  
17 for an additional one-year term; and

1       **WHEREAS**, the Department of Public Works of Jefferson County, Missouri, was  
2 informed that Joe's Plumbing Drain & Sewer Service, LLC could not renew the On-Call  
3 Sewer Contractor Contract now; and

4       **WHEREAS**, the Department of Public Works of Jefferson County, Missouri,  
5 Council finds it is in the best interest of the County to renew the bid award for On-Call  
6 Sewer Contractor Contract for the term of 2-8-17 to 2-7-18 with Drain Surgeons with  
7 approval of the County Council and County Executive up to the amount of **\$50,000.00**  
8 subject to budgetary limitations.

2 Section 2. The Jefferson County, Missouri, Council hereby authorizes the

6 Section 3. Copies of all Invitations for Bid, Requests for Proposals, responses  
7 thereto, and any contracts or agreements shall be maintained by the Department of the  
8 County Clerk consistent with the rules and procedures for the maintenance and retention  
9 of records as promulgated by the Secretary of State.

10 Section 4. This Ordinance shall be in full force and effect from and after its  
11 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity  
12 shall not affect the remainder of this Ordinance.




