1 **AN ORDINANCE TO AUTHORIZE THE COUNTY EXECUTIVE TO**
2 **EXECUTE CHANGE ORDER NO. 1 FOR THE PROPANE GAS 2016 CONTRACT**
3 **FOR THE JEFFERSON COUNTY, MISSOURI, DEPARTMENT OF PUBLIC**
4 **WORKS.**

5 **WHEREAS**, Pursuant to Ordinances, 15-0576 and 16-0512, Jefferson County,
6 Missouri and the Department of Public Works entered into a Contract with Gateway FS for
7 the Propane Gas 2016 Contract; and,

8 **WHEREAS**, the Department of Public Works of Jefferson County, Missouri finds
9 that it is now necessary to adjust the estimated amount to reflect the increase in the propane
10 gas due to market volatility for the needs for the Propane Gas 2016 Contract; and,

11 **WHEREAS**, the Department of Public Works of Jefferson County, Missouri
12 renewed the contract for the Propane Gas 2016 Contract for the same terms and conditions in
13 October 2016; and

14 **WHEREAS**, Jefferson County, Missouri, and the Department of Public Works for
15 Jefferson County, hereby request an increase from Gateway FS from the original contract
16 cost of \$1.02 per gallon to \$1.04 per gallon to cover the rising cost of propane gas; and,

17 **WHEREAS**, Jefferson County, Missouri, and the Department of Public Works for

1 County to execute Change Order No. 1 to the Propane Gas 2016 Contract, for an increase of
2 \$1.02 per gallon to \$1.04 per gallon for the propane gas with Gateway FS, upon approval by
3 the County Council and County Executive.

**BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,
AS FOLLOWS:**

4 Section 1. The Contract with Gateway FS for the Propane Gas 2016 Contract
5 shall be increased from \$1.02 per gallon to \$1.04 per gallon, by Reference as Exhibit "A"
6 subject to budgetary limitations upon approval by the County Council and County Executive.

7 Section 2. The Jefferson County, Missouri, Council hereby authorizes the County
8 Executive to execute Change Order No. 1 to the Propane Gas 2016 Contract and any
9 agreements or contracts necessary to effectuate the award of the bids and proposals set forth
10 in this Ordinance. The County Executive is further authorized to take any and all actions
11 necessary to carry out the intent of this Ordinance.

12 Section 3. Copies of all Invitations for Bid, response thereto, any contract
13 agreements and change orders shall be maintained by the Department of the County Clerk
14 consistent with the rules and procedures for the maintenance and retention of records as
15 promulgated by the Secretary of State.

16 Section 4. This Ordinance shall be in full force and effect from and after its date
17 of approval. If any part of this Ordinance is invalid for any reason, such invalidity shall not
18 affect the remainder of this Ordinance.

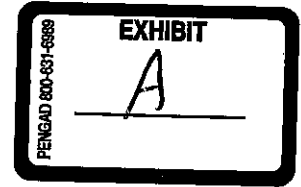

Jefferson County Missouri (Patron Name) Acct# 2246975 of

Hillsboro, MO (City), IL, hereinafter referred to as "Buyer" agrees to

purchase from Gateway FS, Inc. of Red Bud, IL, hereinafter referred to as "Seller",
_____ 20000 gallons of LP Gas according to the following terms and conditions:

1. The price for the above stated gallons shall be \$ 1.04 per gallon.
2. Seller shall deliver LP Gas in reasonable quantities and at reasonable times so as to be able to service the Buyer on a "Keep Full" basis.
3. Buyer agrees to accept delivery of all contracted gallons of LP Gas on September 1, 2017 or before March 31, 2018.
4. LP Gas will be invoiced at the time of delivery.
5. All invoices are subject to applicable taxes.
6. Buyer agrees to pay all invoices in accordance with the credit policy of the Seller.
7. This contract is valid only for the quantity stated above. Additional LP Gas will be invoiced at the prevailing posted retail price, less any discounts that may apply.
8. Due to market volatility, this contract must be signed and post marked on or before August 18, 2017 for this contract to be considered valid.
