1           **WHEREAS**, the Department of County Services and Code Enforcement, Division  
2 of Animal Control of Jefferson County, Missouri, finds it is in the best interest of the  
3 County to renew the bid award for Rebid Attending Veterinarian Services 2017 for the  
4 term of 1-1-2018 to 12-31-2018 with St. Louis Vet Center with approval of the County  
5 Council and County Executive up to **\$25,000.00 per year, for total amount not to exceed**

9           Section 4.     This Ordinance shall be in full force and effect from and after its  
10 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity  
11 shall not affect the remainder of this Ordinance.
