Land Disturbance permits fees:

- 1-3 Acres = \$500.00 + \$50.00/acre
- >3-10 Acres = \$1000.00 + \$50.00/acre
- >10-25 acres = \$1500.00 + \$25.00/acre for every acre, or part thereof, over 10 acres
- >25 Acres = \$1875.00 + \$10.00/acre for every acre, or part thereof, over 25 acres
